Venture Scotland, a charity (SC013901) working in the outdoors with some of Scotland's most vulnerable young people (YP) who are struggling with their mental health. We received £8,000 from the Nineveh Trust on 6 August 2020.

• Has the project we helped to fund been completed? If so, how is it maintained? Yes – the project has been completed. We received funding to support the salary costs of an Outdoor Youth Worker (OYW) - total costs £28,000. The rest of the costs were fully match funded by other funders (see more detail below).

Yes – the funds were spent in full as per our application.

## Tell us about the project

• Has the project been successful and well received by the beneficiaries?

By supporting the costs of our OYW in our Glasgow base, we have supported 21 vulnerable YP from the Greater Glasgow areas, through the Covid-19 lockdown, of whom 12 competed our Challenge Programme and 7 completed our Discover Programme.

We asked our YP to report on their experiences and our work. The results were as follows:

- 91% felt less isolated since engaging with Venture Scotland.
- 64% felt that they had gained new friendships/contacts I can call on.
- 73% felt that their opinion mattered.
- 73% felt that they were more comfortable using greenspace and local parks.
- 100% felt valued.
- 100% felt they gained confidence.
- 100% felt their mental/emotional health was better.

"Always knowing that there is someone to talk to you if needed, which I did! In lockdown Venture Scotland provided needed structure for me. It was something to look forward to every week. It felt like I still had connection to people." Jim (pseudonym), 2020



• Are you satisfied with the outcome, or, with hindsight, would some modifications have been appropriate?

We were satisfied with this outcome as we had to make some fundamental changes to our delivery due to the Covid-19 restrictions in place during this time. We adapted our Challenge Programme to be delivered and completed entirely online and managed to meet our YP at locations (in a Covid-safe way) in order to deliver our Discover Programme to groups of YP in the outdoors
