Friends of the Ullswater Way. Grant of £4,500. Approval notified on 24thFebruary 2021

Tell us about the Funds

- Has the project we helped to fund been completed? If so, how is it maintained?

The Ullswater Heritage Knowledge Bank and Website were formally launched on September 29th 2021. The Nineveh Trust was invited to attend but unfortunately was unable to do so. FOUW is run entirely by volunteers. We will still have a demand for some specialist, notably IT, advice.

- If not completed yet, why not? Are plans in place to finalise the project?

The launch of the knowledge bank and website was the first element of a wider initiative to create more awareness and appreciation of the natural and cultural heritage of the Ullswater Valley. Our plans are to extend its application in schools, and develop interactive kiosks and table tops when COVID allows.

- Did the funds provided by us prove adequate, or was there an over- or under-spend?

So far there is an underspend because we have not needed to purchase laptops/IPADs, our legal advice has been provided *pro bono*, and we have not needed as many line drawings as expected.

- How were any surplus funds used, or was further funding made available?

We would like to seek authorisation from you to re-allocate some of the funds available for other tasks: production of posters and leaflets as well as prototype interactive kiosks /tables for users.
