Nell Bank Charitable Trust, £4,000 donated in June 2021

Tell us about the Funds

- Has the project we helped to fund been completed? If so, how is it maintained?

We asked for a donation to support the Reboot 2021 Wellbeing in Wellies campaign. The first phase of the campaign has been successful and has offered visits for just £1 each for 565 children in total. The Nineveh donation has funded approximately 250 of these places.

- If not completed yet, why not? Are plans in place to finalise the project?

- Did the funds provided by us prove adequate, or was there an over- or under-spend?

We initially asked for £8,400 and the donation was scaled back to £4,000. The donation was sufficient to fund approximately half of the first phase of the campaign.

- How were any surplus funds used, or was further funding made available?

There were no surplus funds. The remainder of the funding has been sourced from other grant providers.

Tell us about the project

- Has the project been successful and well received by the beneficiaries?

The project has been extremely successful and feedback received has been very positive. The children visiting the Nell Bank Centre have taken part in programmes which focus on health and wellbeing and social development alongside building of knowledge of the natural environment.

We are satisfied with the outcome of the campaign and continue to raise funds to provide or assist with the cost of visits for children to Nell Bank. The second phase of the programme encouraged the families of the children included in phase one and members of the public to come to a Nell Bank Discovery Day in the summer. This phase was also very successful.

Yes and funding continues to be sought.

Children have visited the centre in class groups and have been encouraged to spend time together, interact positively and play together, addressing the social skills development that children were missed as a result of restrictions and school closures.
